In order to offer the best virtual experience for its customers and visitors to the Website, Tecto may use cookies in a responsible, clear and respectful manner with its users, as described below.

Changes and updates may be made to this Cookies Policy, according to the need and evaluation of Tecto. Therefore, we recommend that users check this page regularly.

1. What is a cookie?

"Cookies" are small text files that store information about your interactions with a website, and can be stored temporarily or permanently on your device's hard drive. They act as a repository of your browsing information.

Cookies play an important role, as they allow Tecto to better understand your browsing preferences, providing more comfort and agility in your experience.

The Tecto website ("Platform") uses cookies to distinguish you from other users, which helps us to offer you a good experience when browsing our Platform and to improve it. These cookies are essential for personalized and effective internet browsing.

It is relevant to mention that cookies do not have access to information on your mobile phone or computer. They only record activities and data generated from your internet browsing and have an expiration date that varies according to the type of cookie.

By continuing to browse, you agree to the use of cookies.

2. Why do we use cookies?

We and our partners use different types of cookies for various purposes.

A. Cookies that do not require user consent:

- **Strictly necessary cookies:** These are cookies that are essential for the operation of our Platform.
- **Analytical and performance cookies:** These allow us to identify and count the number of visitors, as well as to observe how users navigate through the Tecto Platform during their use. This helps us, for example, to improve the performance of the Platform, ensuring that Users can find what they are looking for easily.

B. Cookies that require user consent:

- **Functionality cookies:** These allow your preferences to be stored and your settings to be remembered, making your browsing more comfortable and efficient.

3. How to refuse or delete cookies?

The acceptance of a cookie depends fundamentally on the user's wishes, which can be changed at any time and free of charge. If you have consented to the storage of cookies on your device when accessing the Platform, the cookies present on the pages and content visited may be temporarily stored in a specific space on your device accessing the Platform.

A cookie management configurator is available so that you can control the cookies used and/or stored on the Platform. At any time, you can modify the settings of the browser you are using.
